All of that certain parcel of land situate in the unincorporated area of Santa Clara County, State of California, more particularly described as follows:

Being a portion of Parcel Six and Parcel Seven as described in the Quitclaim Deed from Morgan Hill Unified School District, who acquired title as Live Oak Union High School District of Santa Clara County to Morgan Hill Unified School District, recorded on May 27, 1992 as Document No. 11379063 of Official Records, Santa Clara County records, being a portion of Lots 64 and 65, as shown on the Map entitled "Morgan Hill Ranch Map No. 3", filed on September 21, 1892 in Book "G" of Maps at Pages 20 and 21 and a portion of Lots 24, 25, 26 and 27, as shown on the Map entitled "Map of the McGrath Addition to Morgan Hill, Being Subdivision of Lot 66 of the Morgan Hill Ranch Map No. 3", filed on September 2, 1893 in Book "H" of Maps at Page 3, all of said Santa Clara County records, more particularly described as follows:

TEMPORARY CONSTRUCTION EASEMENT (T.C.E.)

BEGINNING at the most westerly corner of said Parcel Six; thence along the northwesterly line of said Parcel Six, North 55° 51' 09" East, 2.49 feet; thence leaving said northwesterly line, South 33° 49' 04" East, 139.52 feet; thence South 34° 28' 56" East, 175.69 feet; thence South 33° 47' 13" East, 36.76 feet; thence North 55° 51' 26" East, 19.90 feet; thence South 34° 47' 08" East, 40.00 feet; thence South 55° 51' 26" West, 20.01 feet; thence South 34° 48' 24" East, 25.73 feet; thence South 34° 03' 41" East, 203.30 feet; thence North 55° 51' 26" East, 20.24 feet; thence South 33° 59' 29" East, 40.00 feet to a point on the southeasterly line of said Parcel Seven; thence along said southeasterly line South 55° 51' 26" West, 20.70 feet; thence leaving said southeasterly line, across Keystone Avenue and said Lots 24, 25, 26 and 27, South 34° 48' 28" East, 163.66 feet to a point on the northwesterly line of that certain parcel of land described in the Grant Deed from Morgan Hill Unified School District, Successors by Merger with Live Oak Union High School District of Santa Clara County to Santa Clara County Transit District, recorded on November 3, 1978 in Book E074 of Official Records at Page 162, said Santa Clara County records; thence along said northwesterly line, South 55° 51' 26" West, 4.18 feet to a point on the southeasterly prolongation of the southwesterly line of said Parcel Seven; thence leaving said northwesterly line, along the southwesterly prolongation of said Parcel Seven and said Parcel Six, North 34° 08' 34" West, 824.64 feet to the POINT OF BEGINNING.
