Morgan Hill Unified School District has maintained regular communication with students, families, staff, and community. MHUSD continues to engage families in regular ELAC, DELAC, and SEAC meetings. In the Spring of 2021, we held ELAC, DELAC, SEAC, Community Forums, and Board meetings with Spanish translation and gathered input from families, staff, and community members for the development of the LCAP and the Expanded Learning Opportunities (ELO) Grant. The input that was provided from our stakeholders during the spring contributed to the development of the ESSER III plan, which is an expansion of the ELO plan (year 3 of the plan). The final [LCAP](#) and [ELO](#) plans were approved in June 2021. An extensive list of our community engagement opportunities is linked in the LCAP document.

The feedback from the stakeholder surveys to allocate ELO and LCFF funds to meet the needs of our unduplicated students was used to support the programs recently implemented this school year. Our LCAP focus goals and ELO actions address the areas of students' support needs. Since the start of the school year, students' in-person have demonstrated an increase of social-emotional distress with varying needs. We have systemized our student supports and data collection to amplify and scale resources and with an eye towards enhancing multi-tiered systems of support as promoted by the California Department of Education. We have continued targeted and intensive academic support for all students, opportunities for extended learning, diverse enrichment activities, increased social emotional learning curriculum access and training, district wide restorative justice training, wellness and mental health access, improved student engagement strategies, and learning acceleration options. Repeatedly, attention to the overall mental health and social emotional needs of all students were remarkable and expressed consistently by multiple stakeholders, especially our young people. In response to student wellness, four Student Voices groups organized and meet monthly at the secondary school sites.

The LCAP and ELO plans were developed with the ESSER III funding source in mind as the 3rd year allocation solution. The LCAP development, which included a series of multiple stakeholder engagement opportunities (see linked LCAP & ELO), coincided with the onset of the release of the ELO grant development. By June 15, 2021, the LCAP and ELO plan were approved by the MHUSD Board. The implementation of the LCAP and ELO actions launched the MHUSD summer programs and the actions set forth in the plans are in progress.

As we obtain data from the actions outlined in the plans, we will continue to reach out to our students, staff, and families to gain insight and feedback which may inform decisions for revisions to meet the diverse evolving needs of our students.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before **October 29, 2021** and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.
