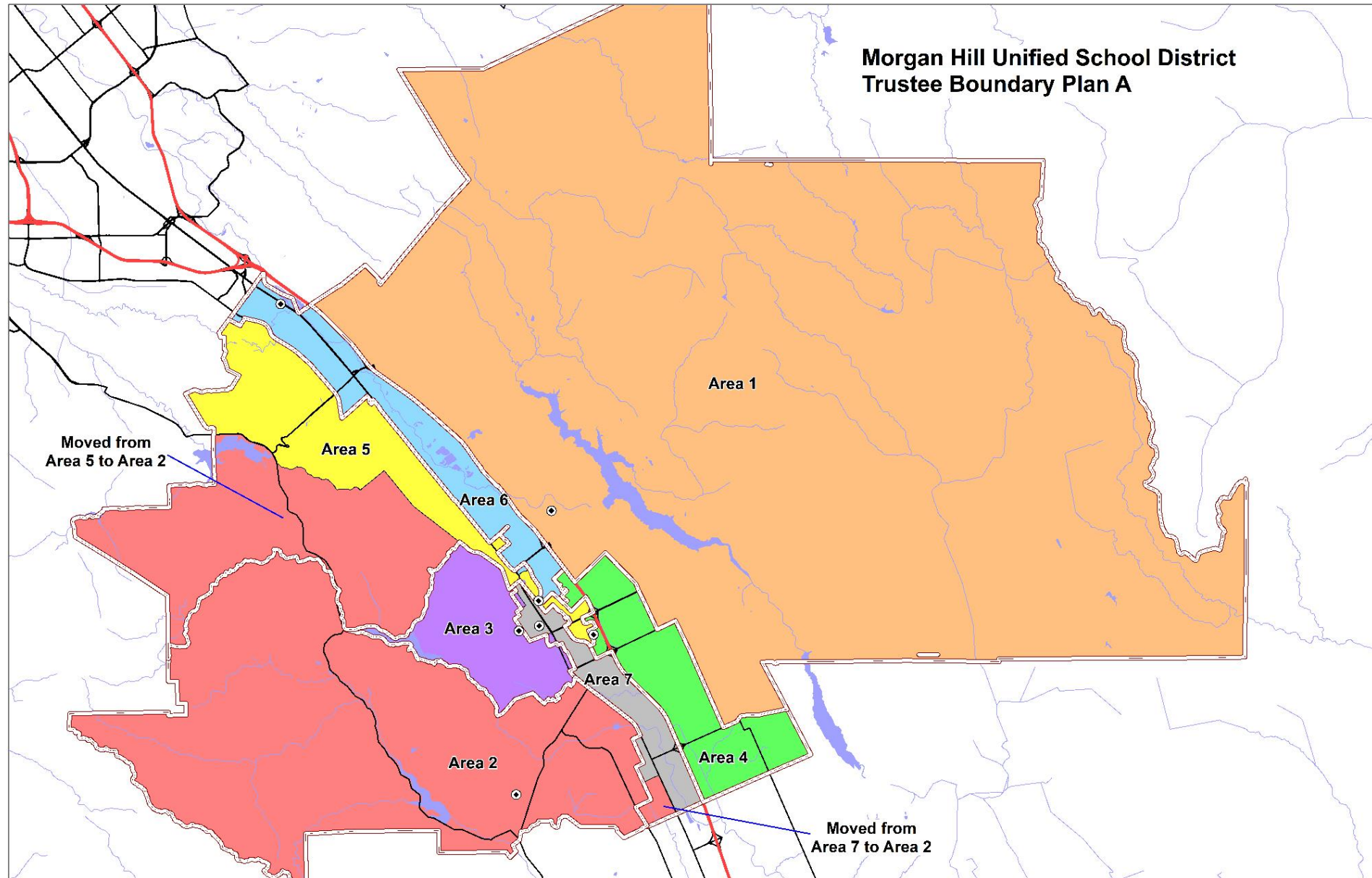


INTRODUCTION

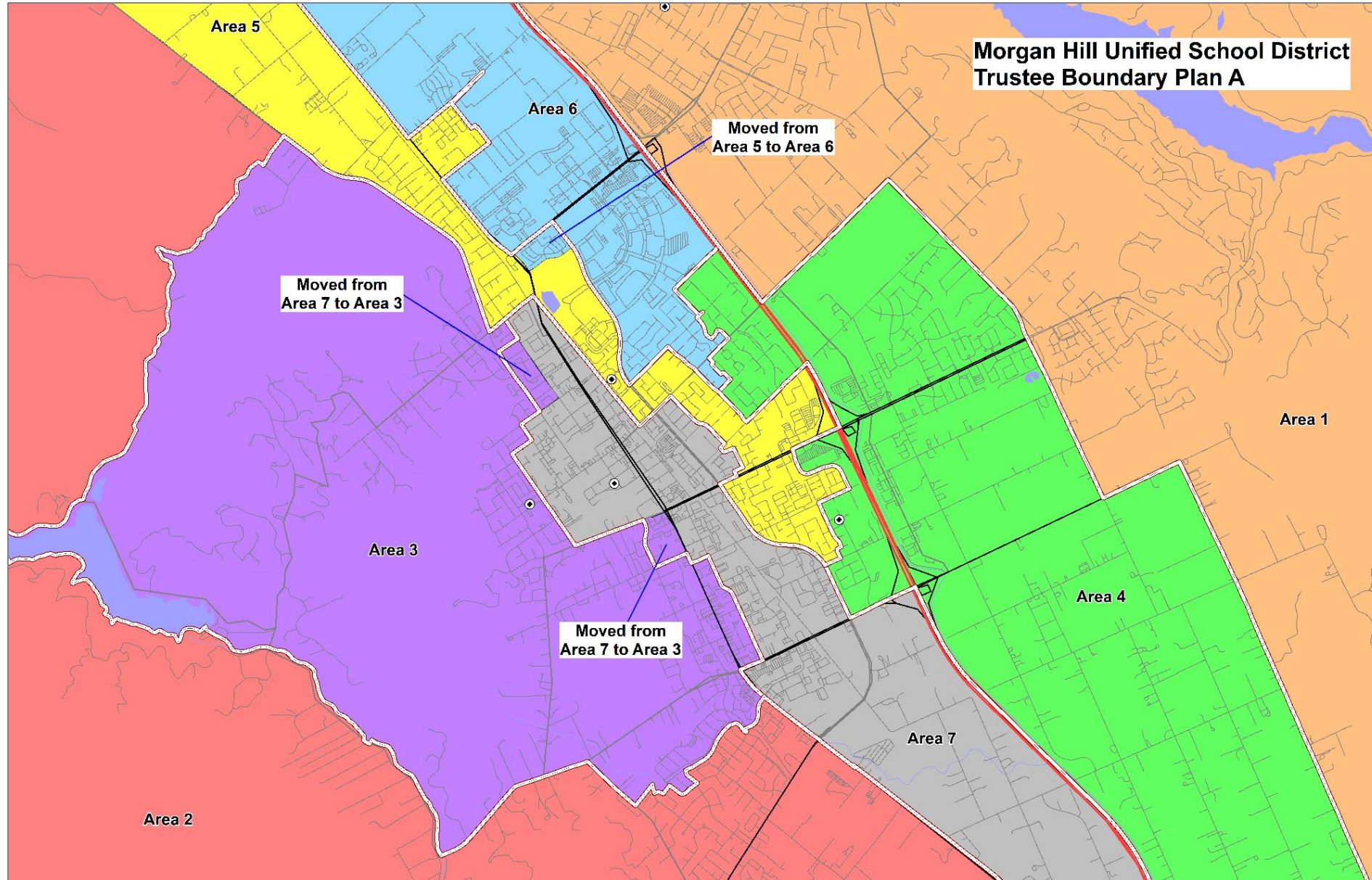
This presentation illustrates several options for the District to re-balance the population for each of the trustee areas..

 - Location of Current Trustees
 - Equal Population
- For each scenario, there are maps showing the boundaries for each trustee area, a table showing the population in each trustee area and the variance from the ideal population. The peak deviation must be less than 10% for the maps to meet the legal requirements. Finally, details of the racial/ethnic populations are provided.

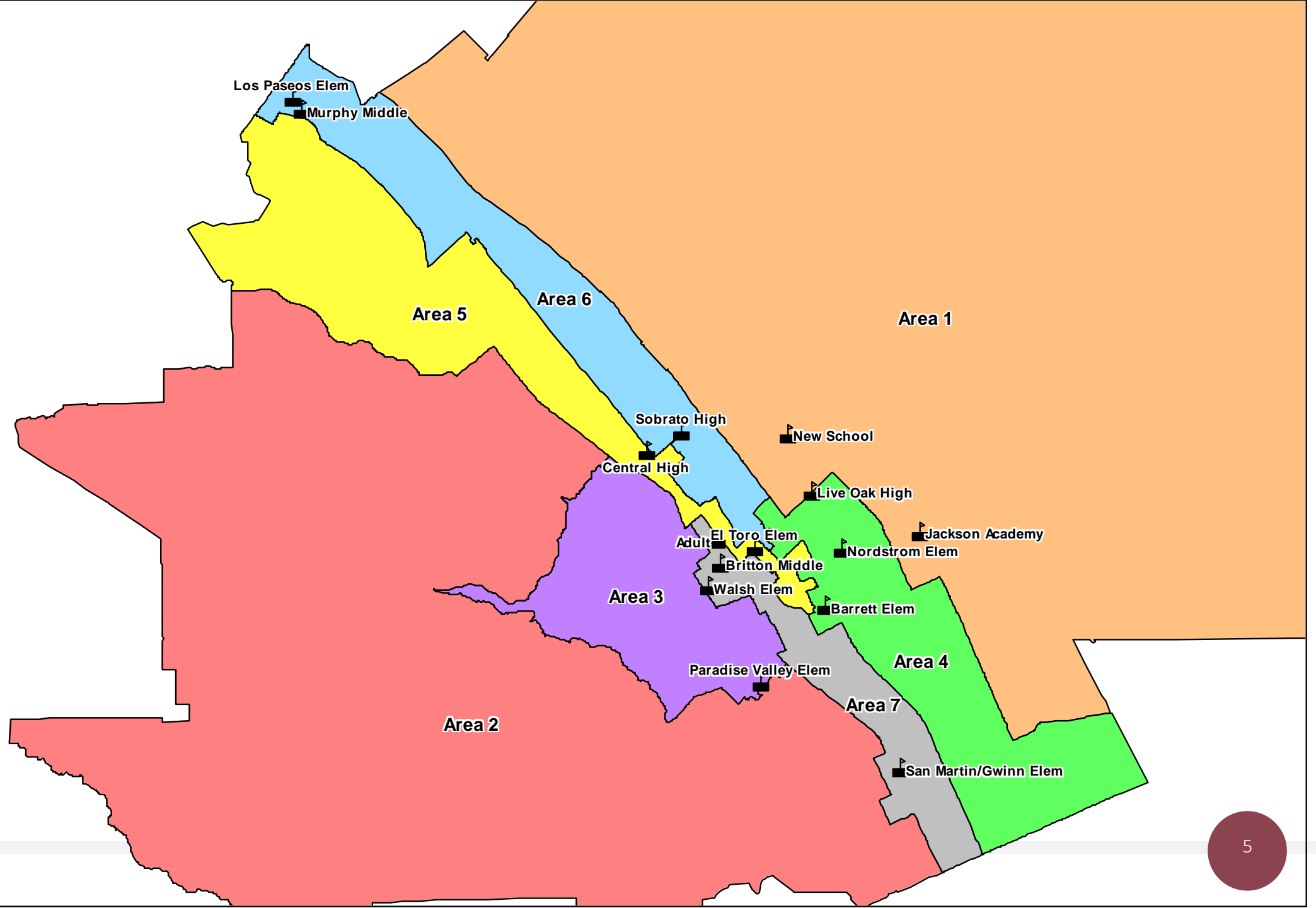
Trustee Area Boundary Map A

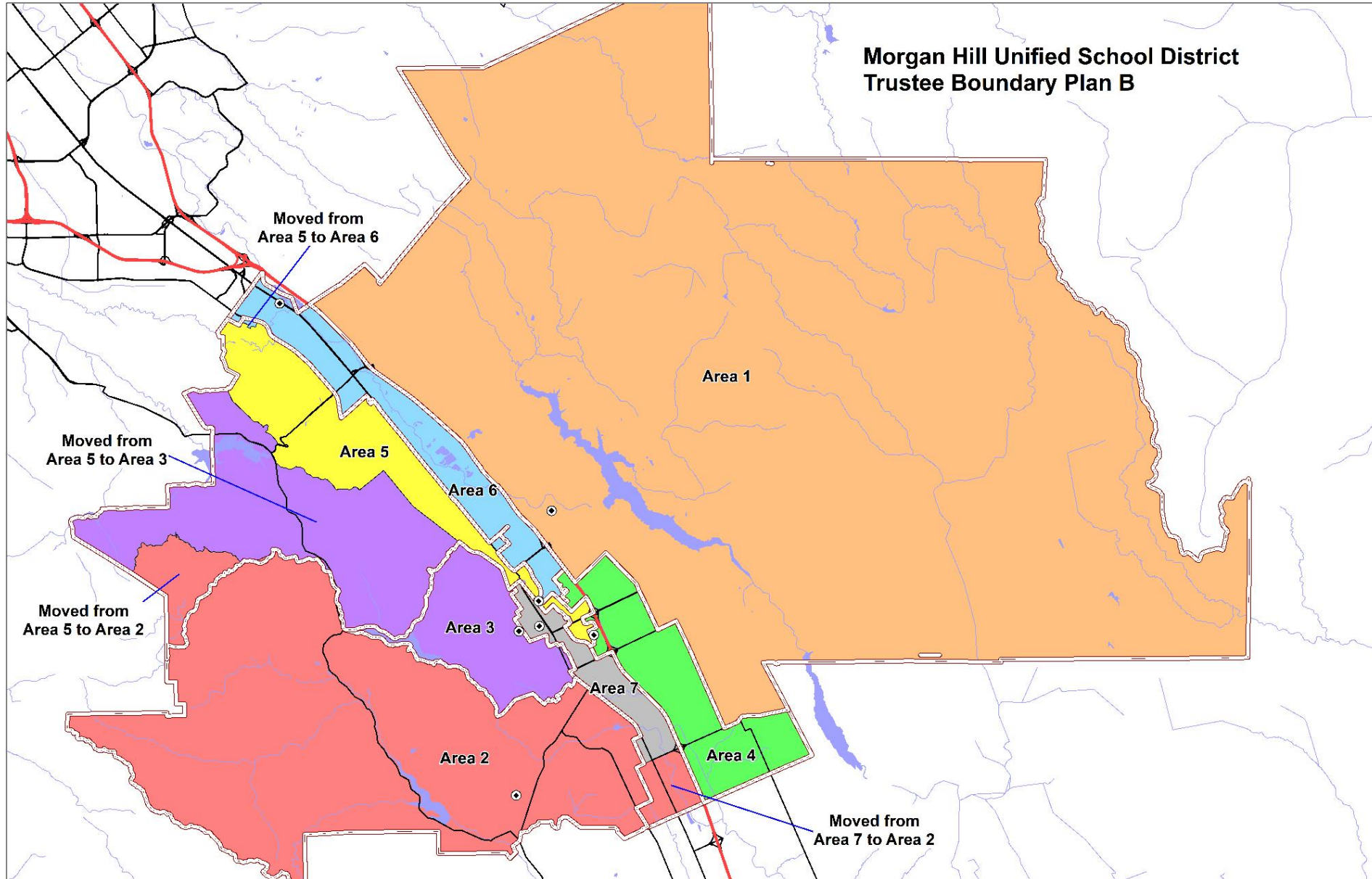

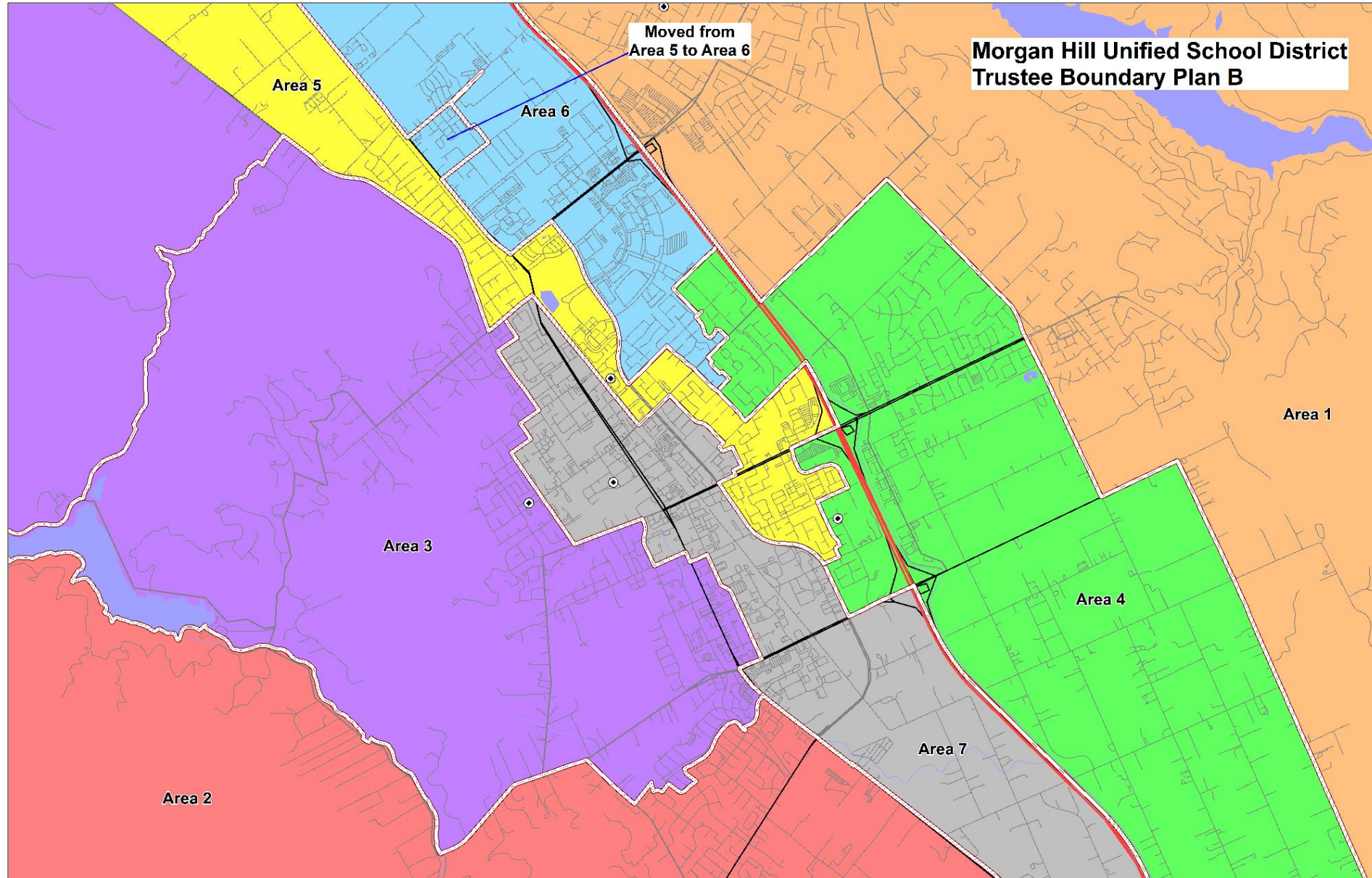

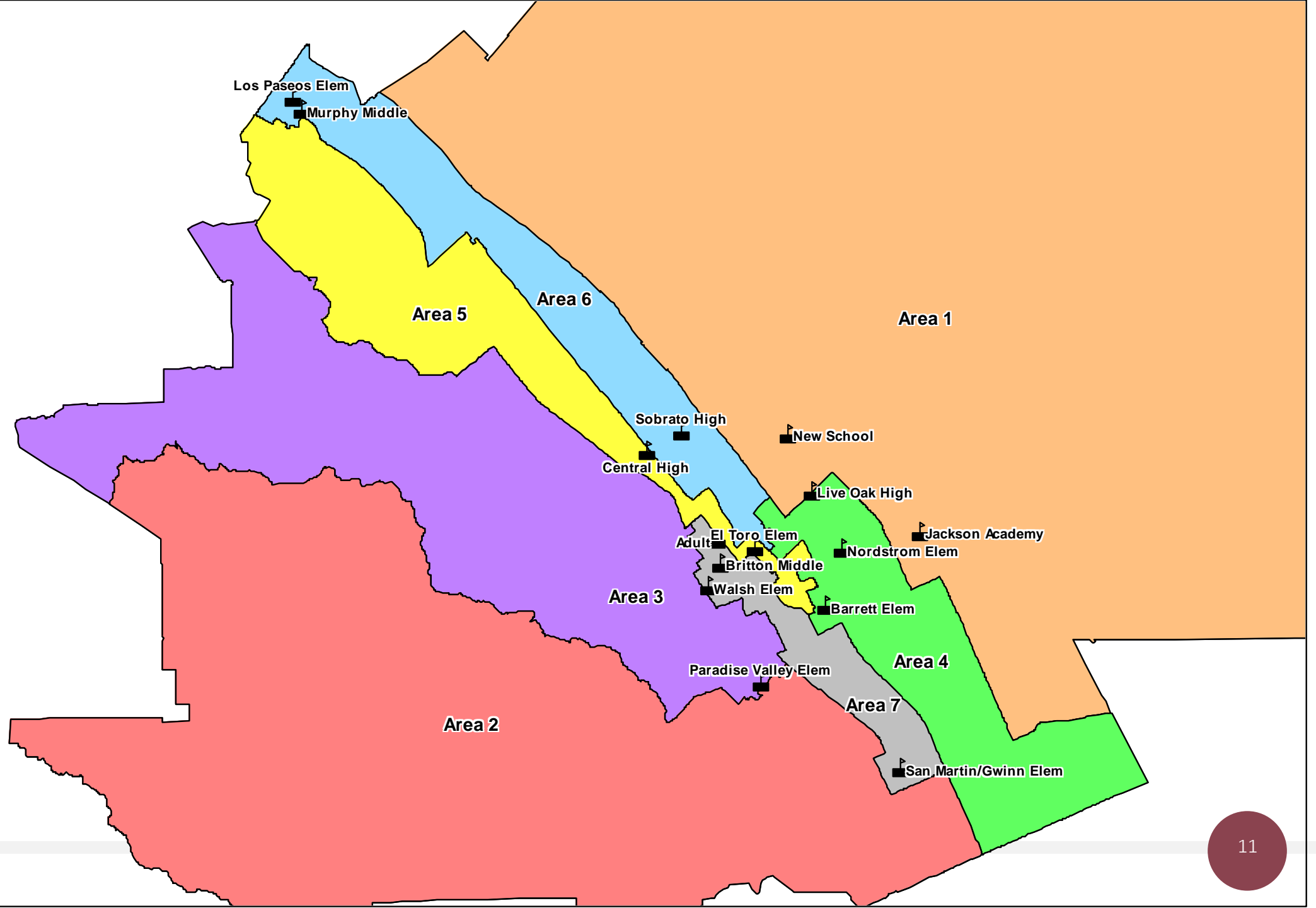
Trustee Area Boundary Map B

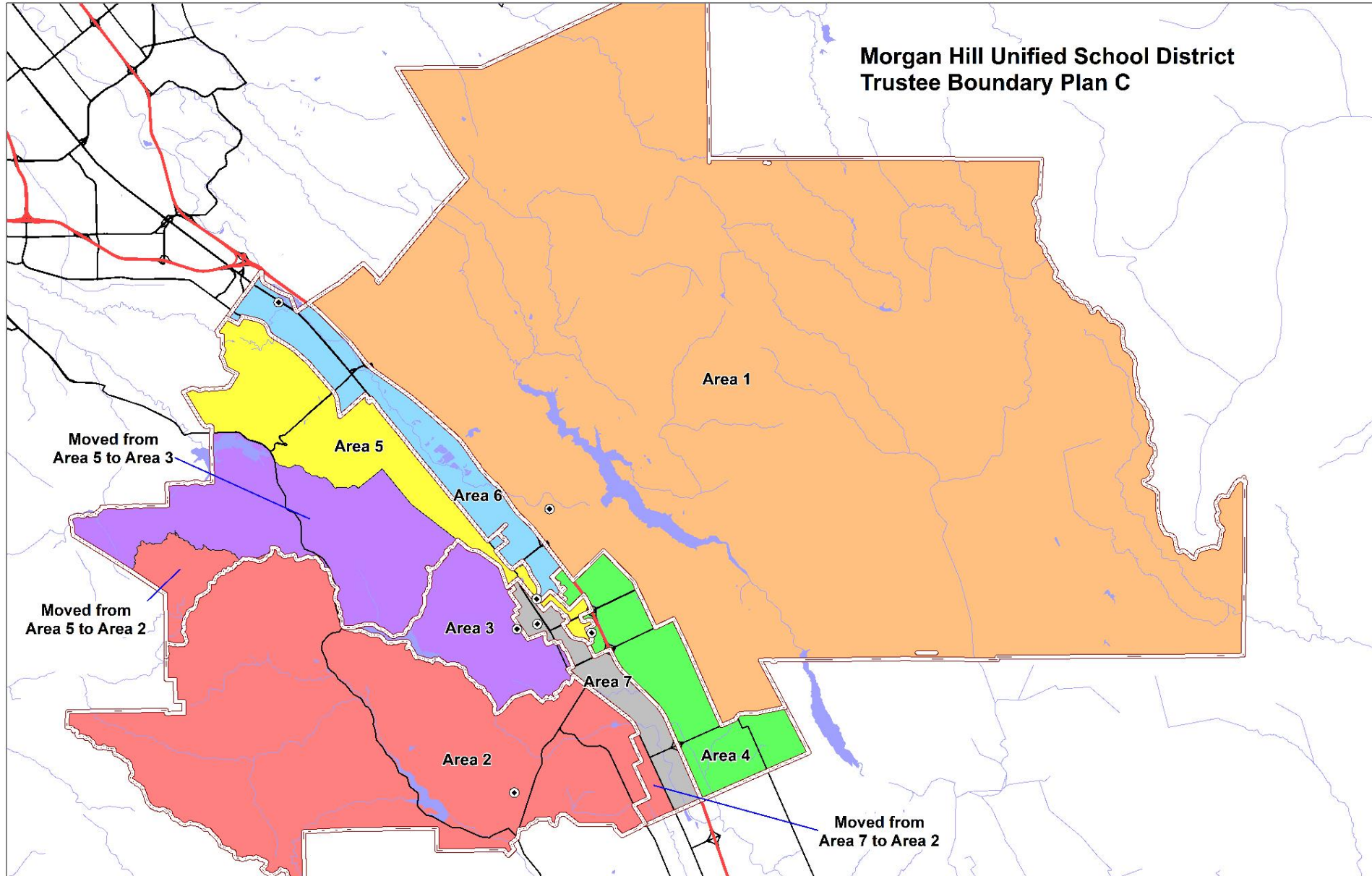

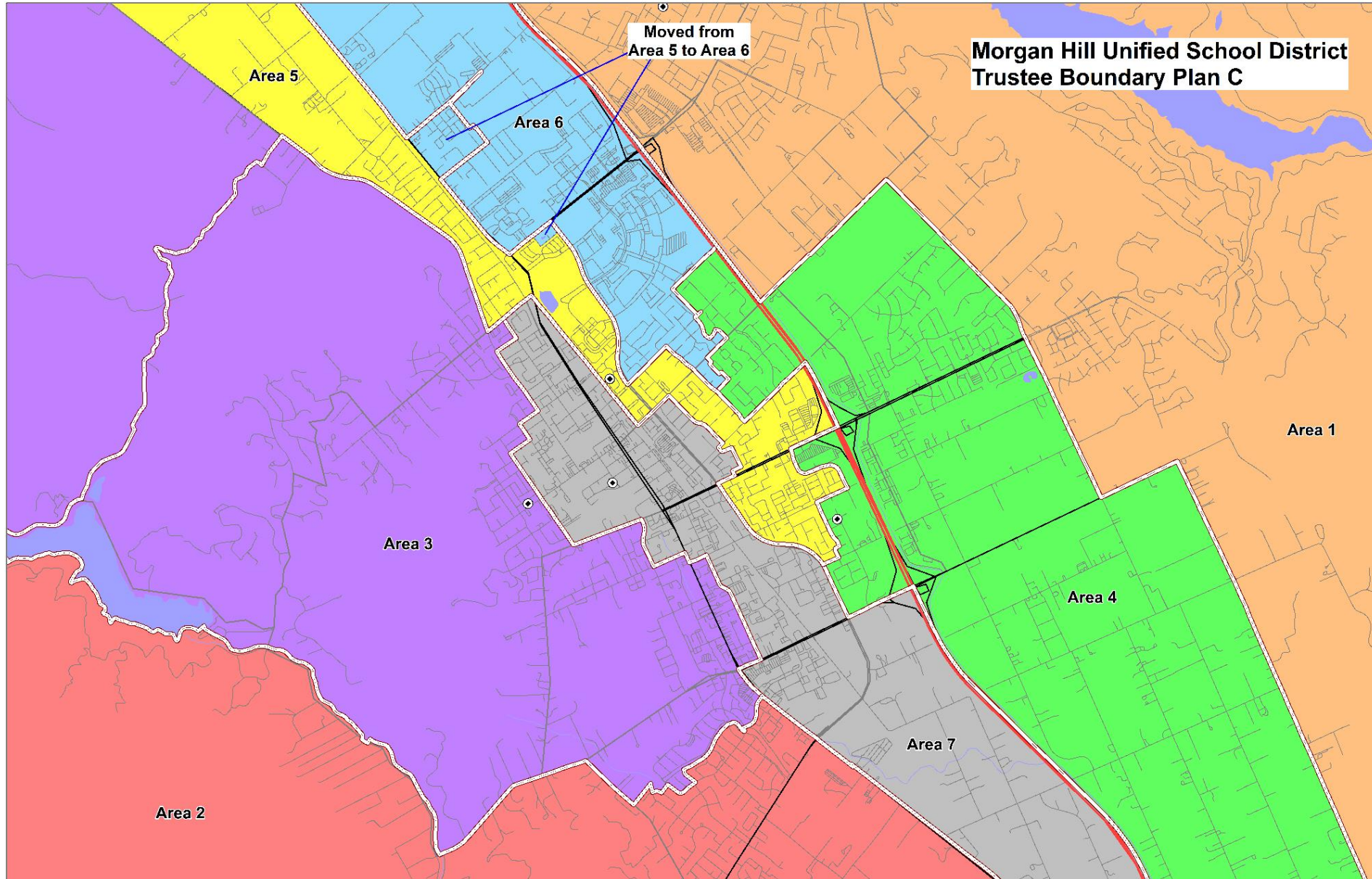

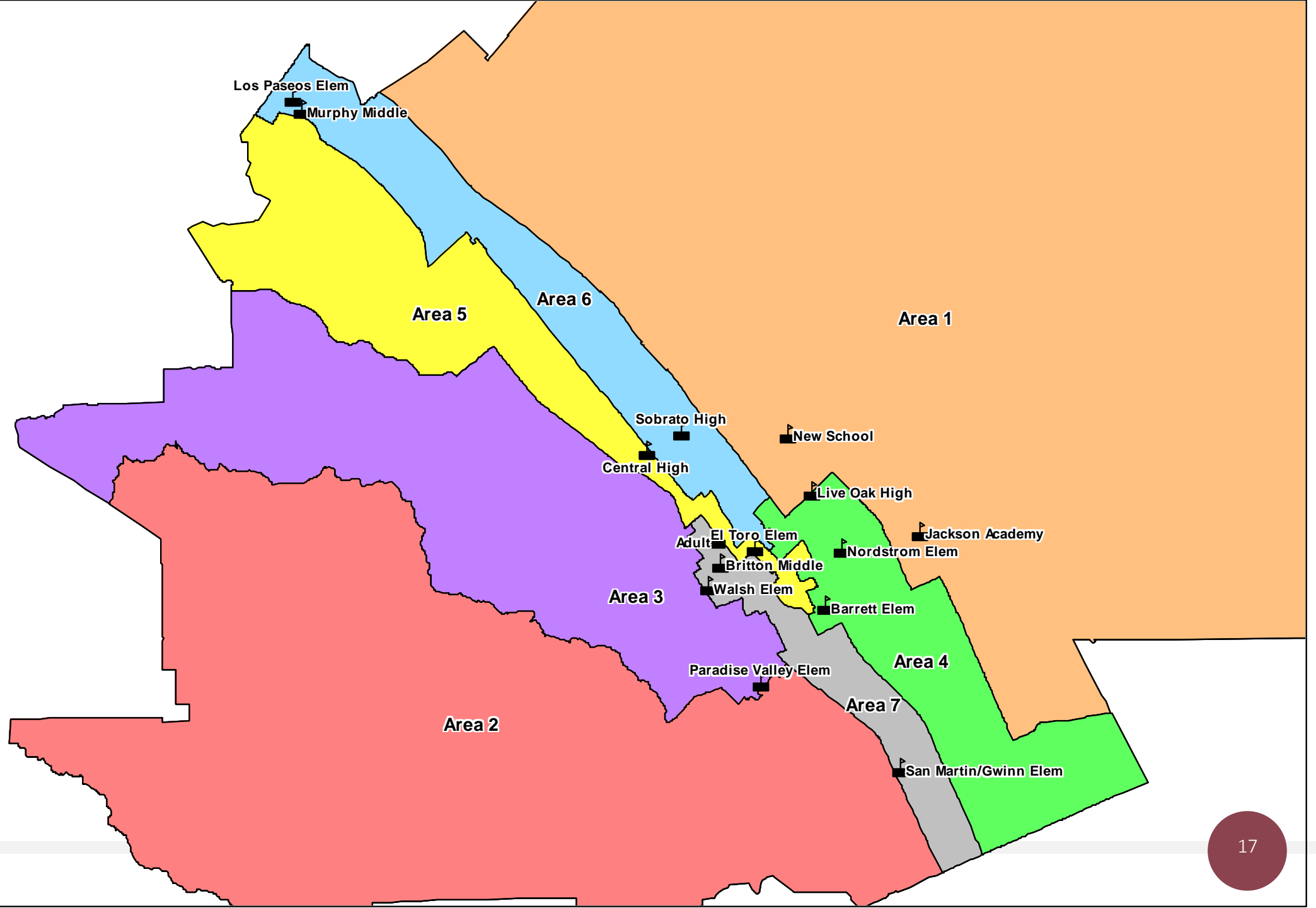
Trustee Area Boundary Map C

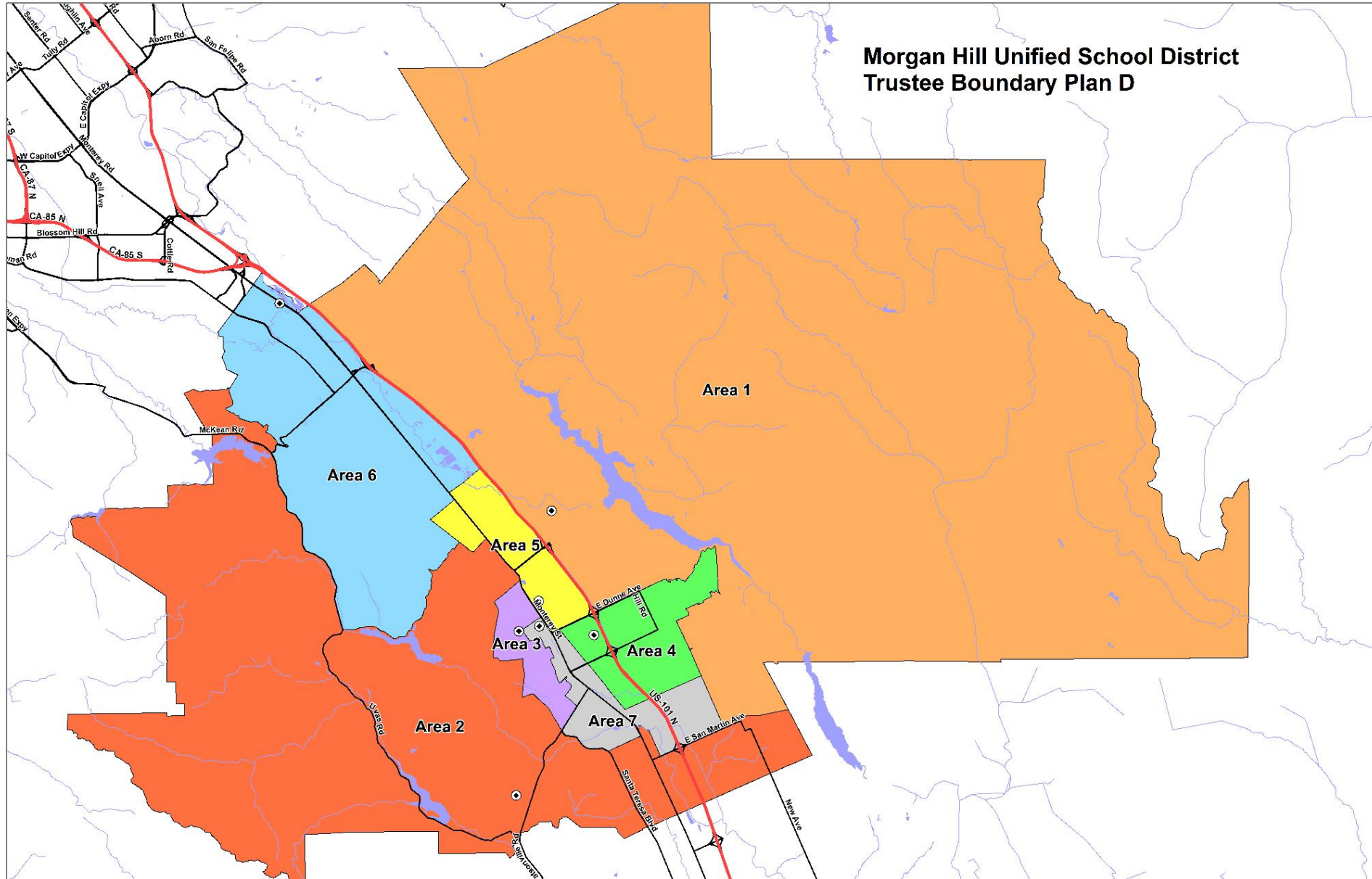

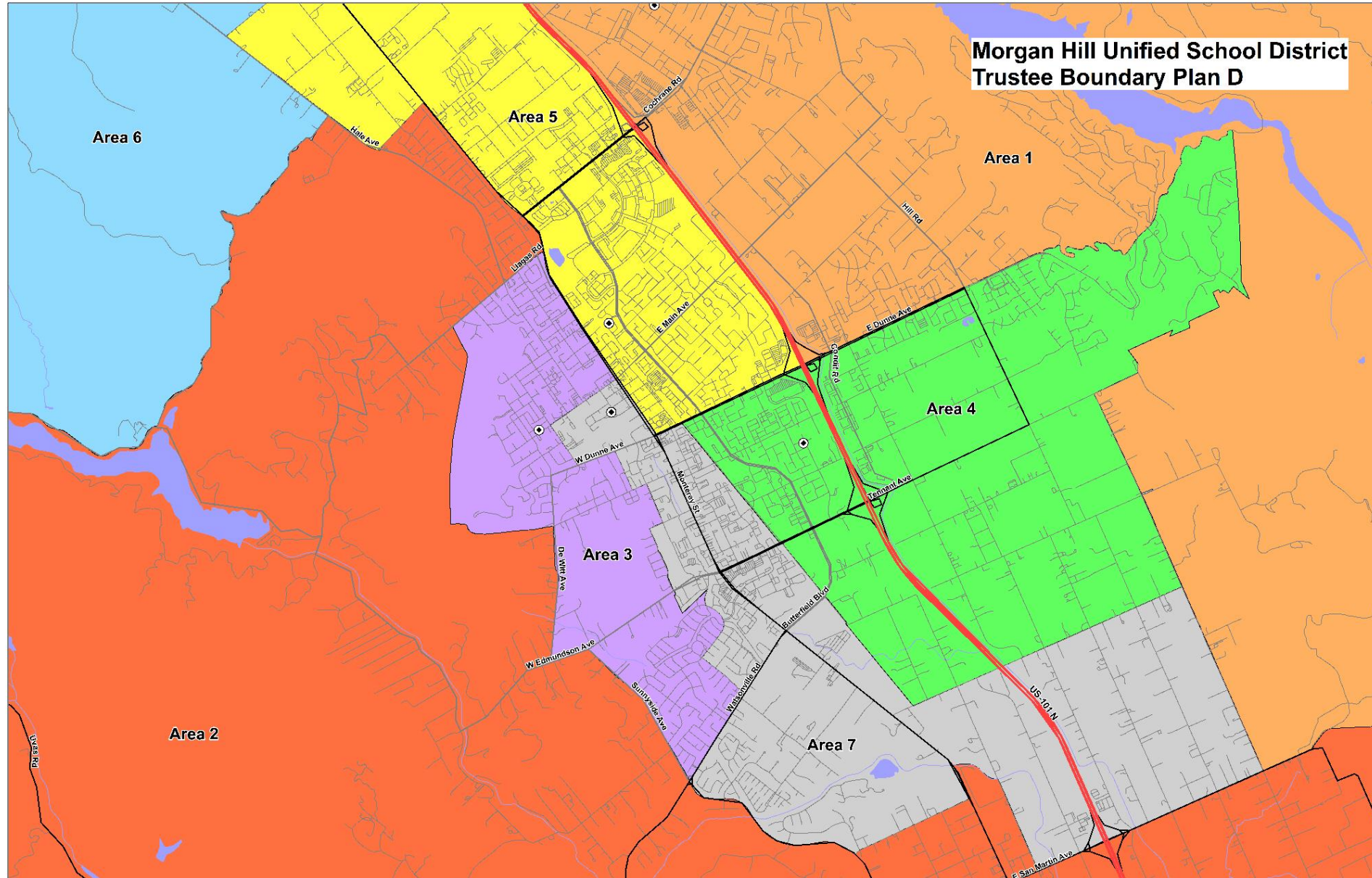

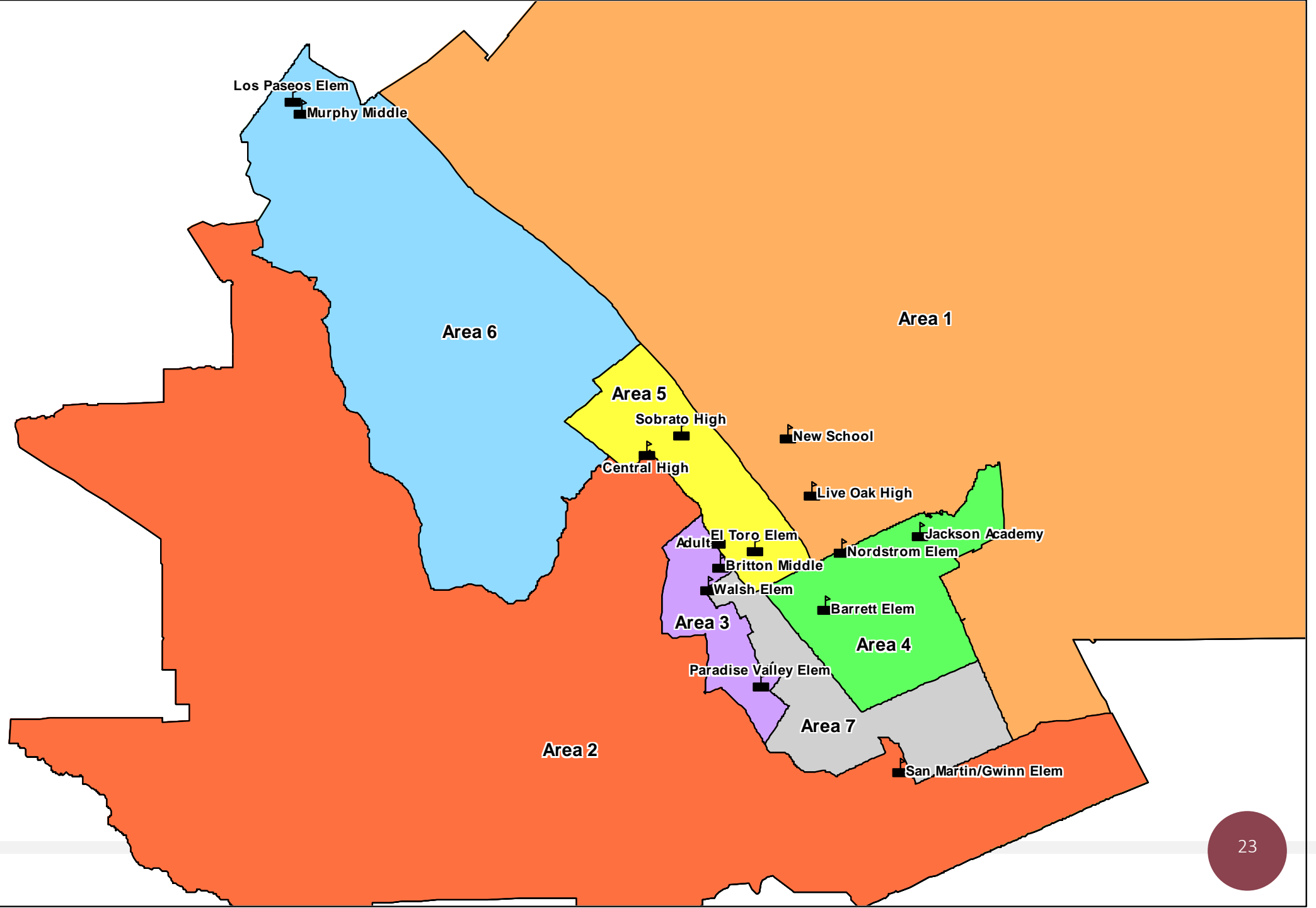
Trustee Area Boundary Map D

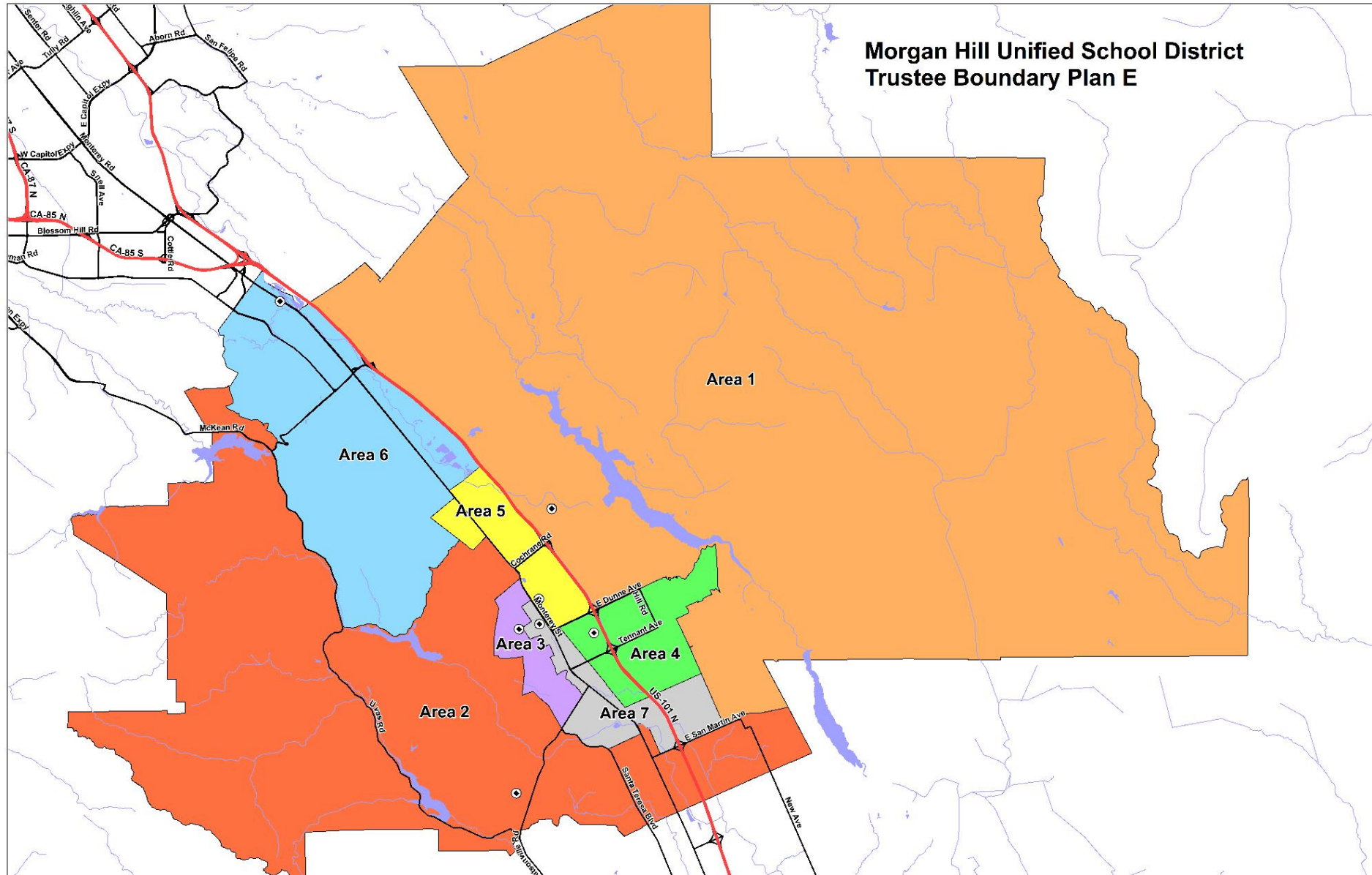

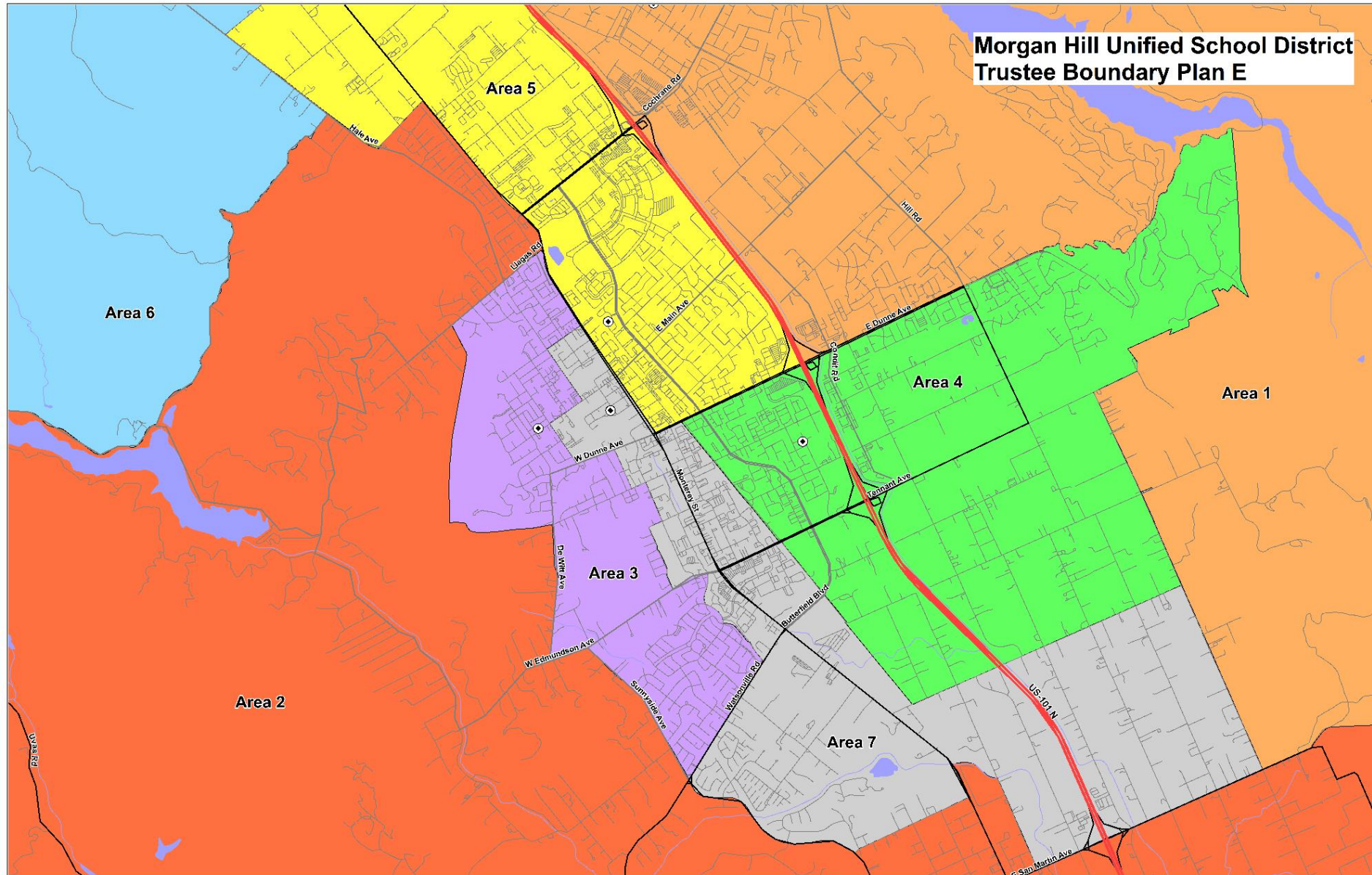

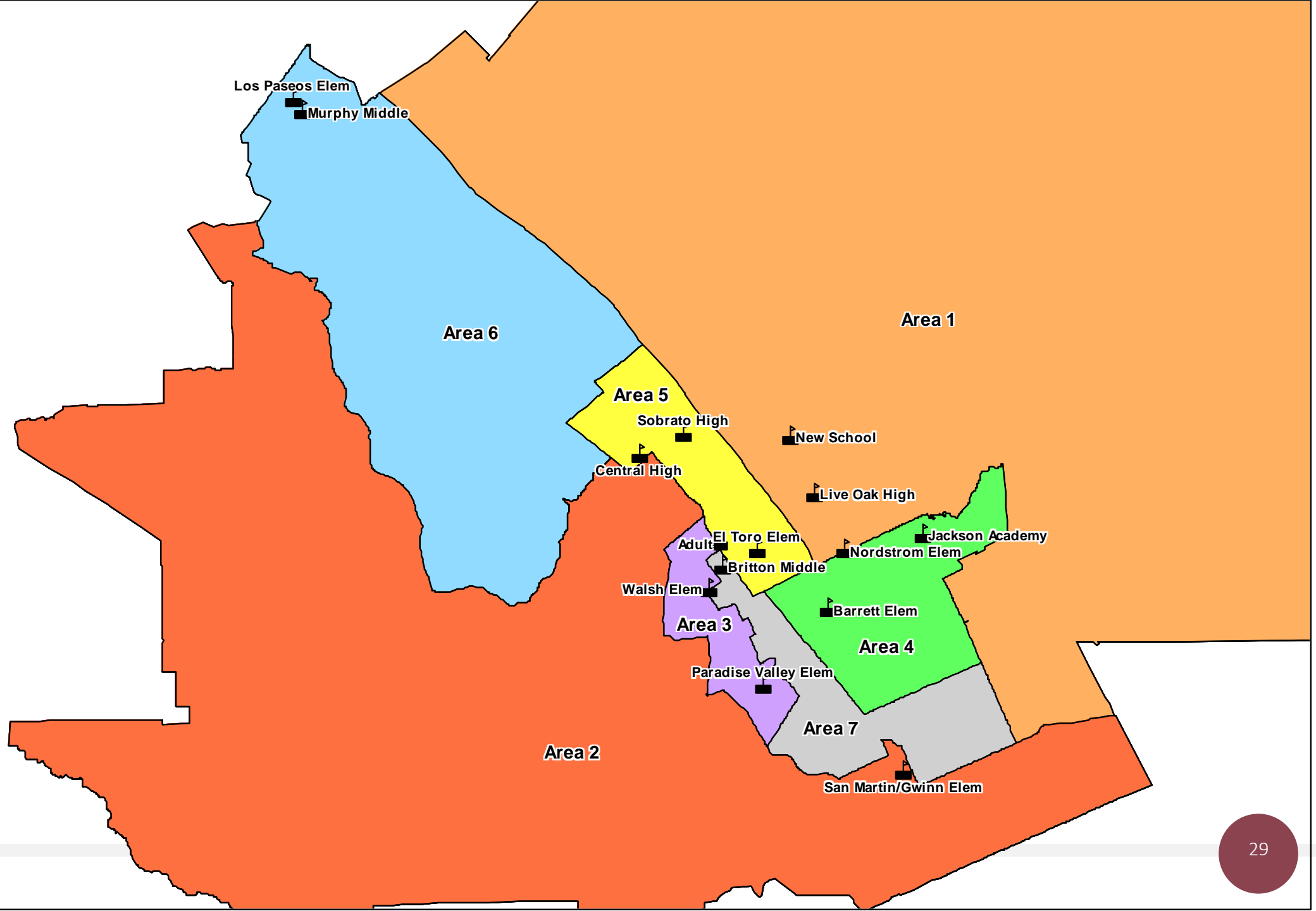
Trustee Area Boundary Map E

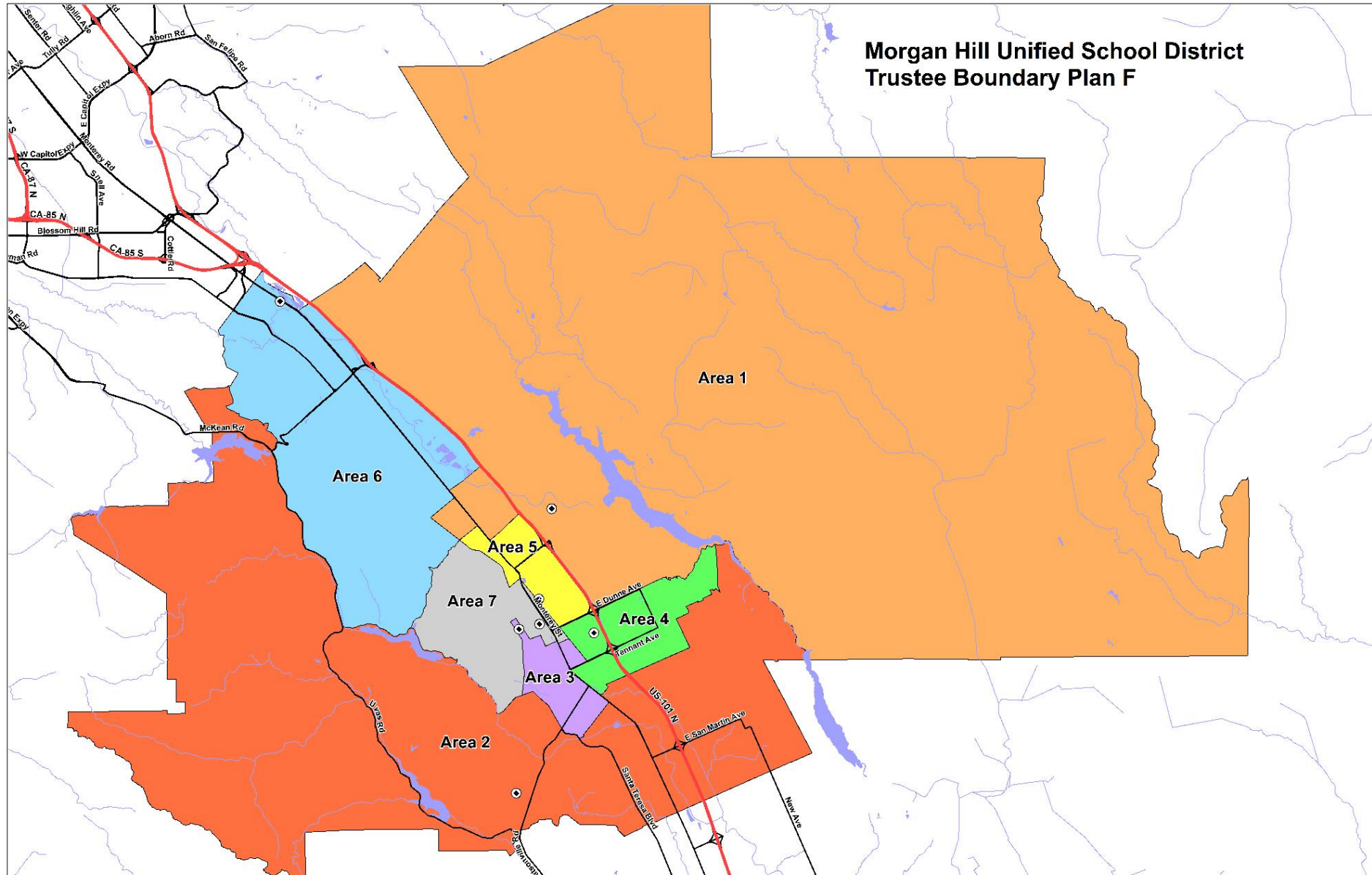

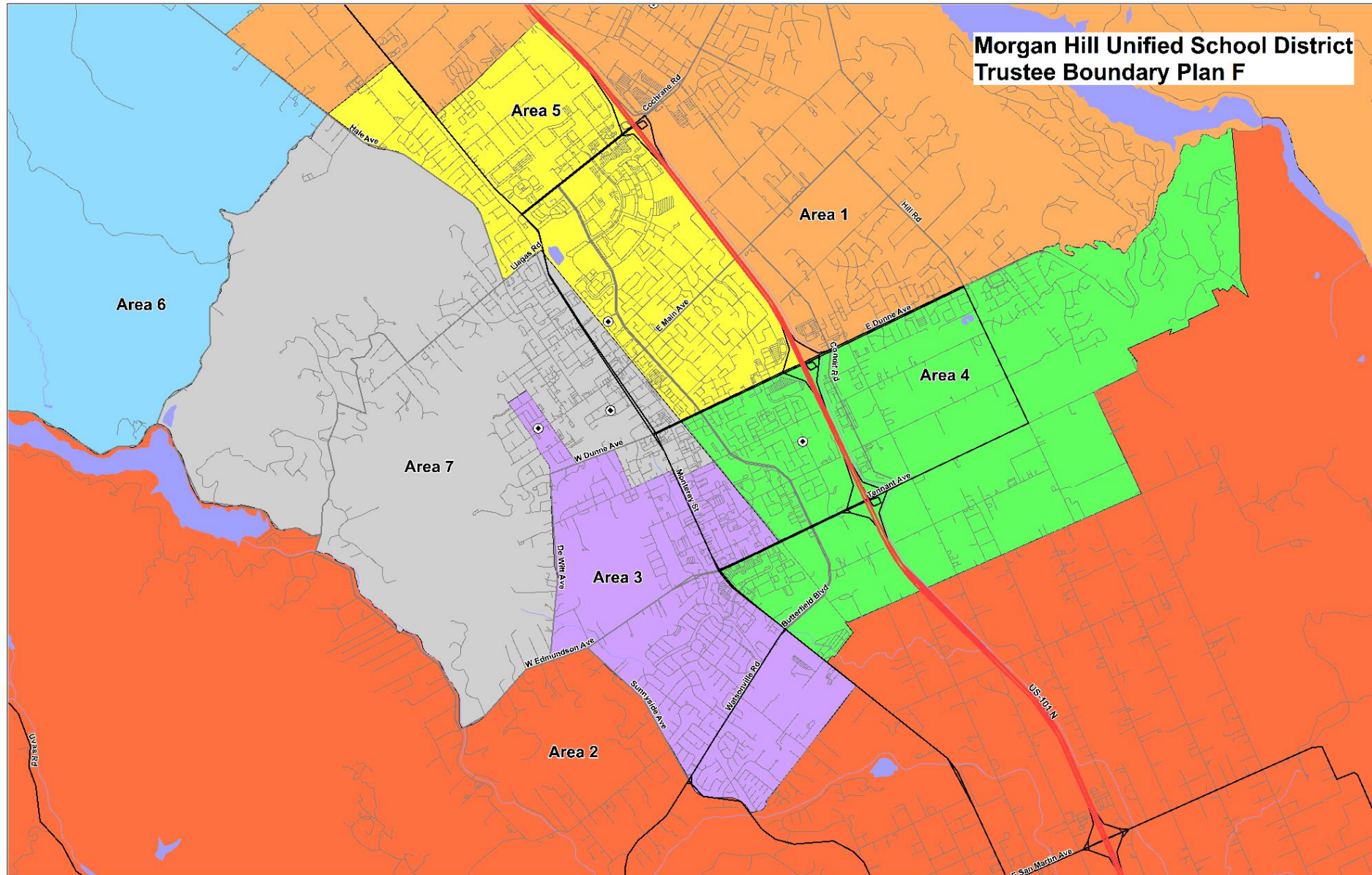

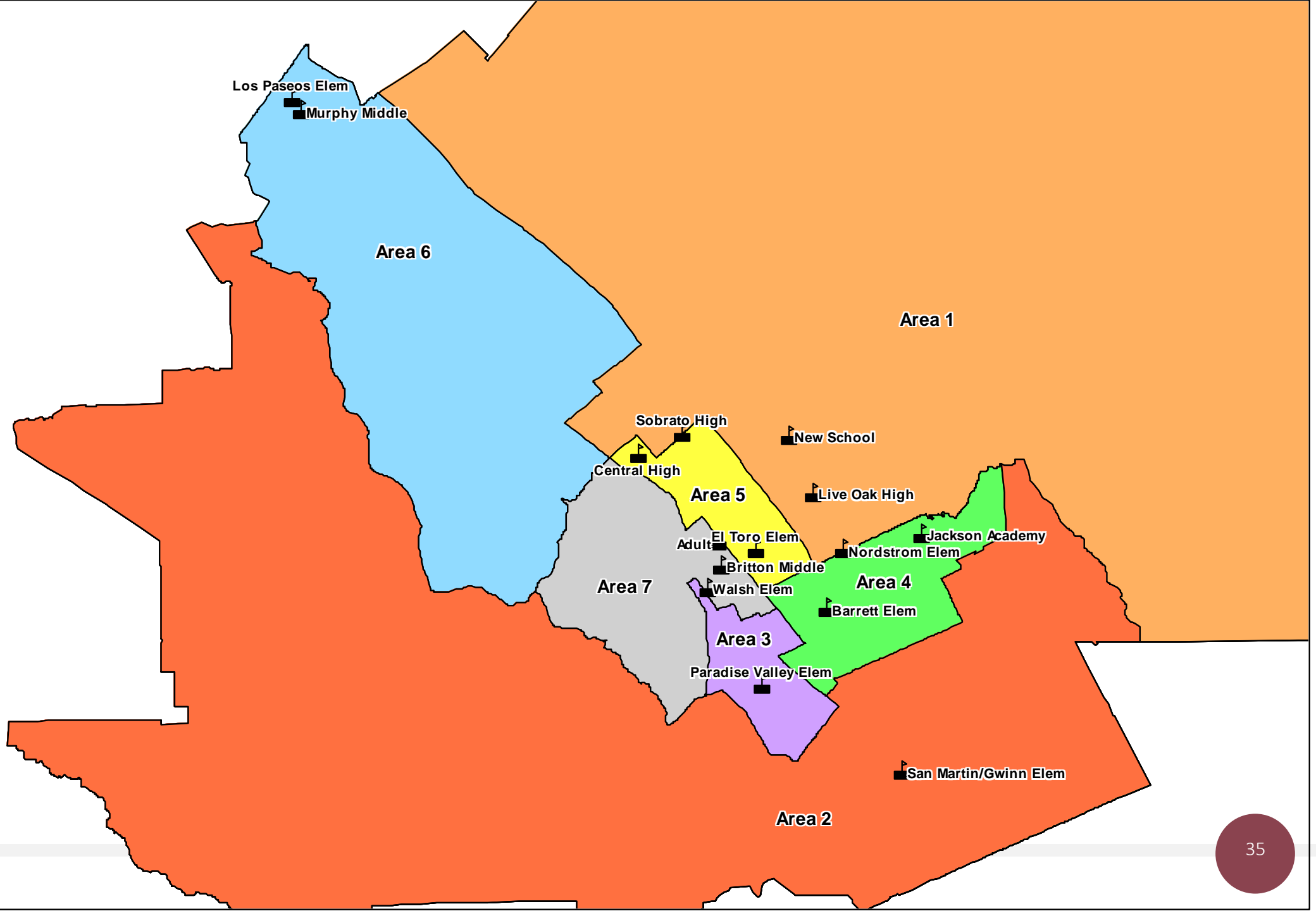
Trustee Area Boundary Map F

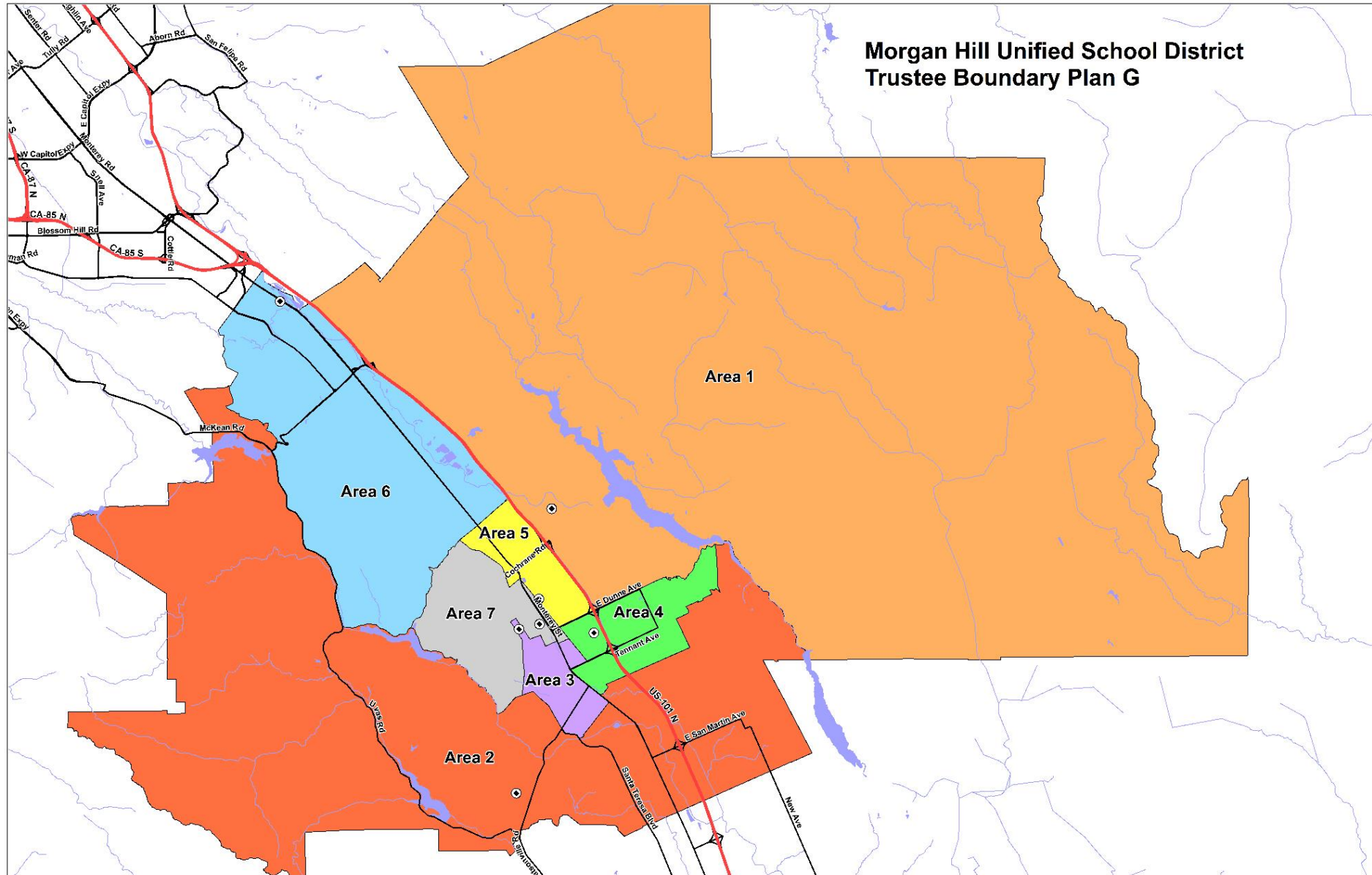

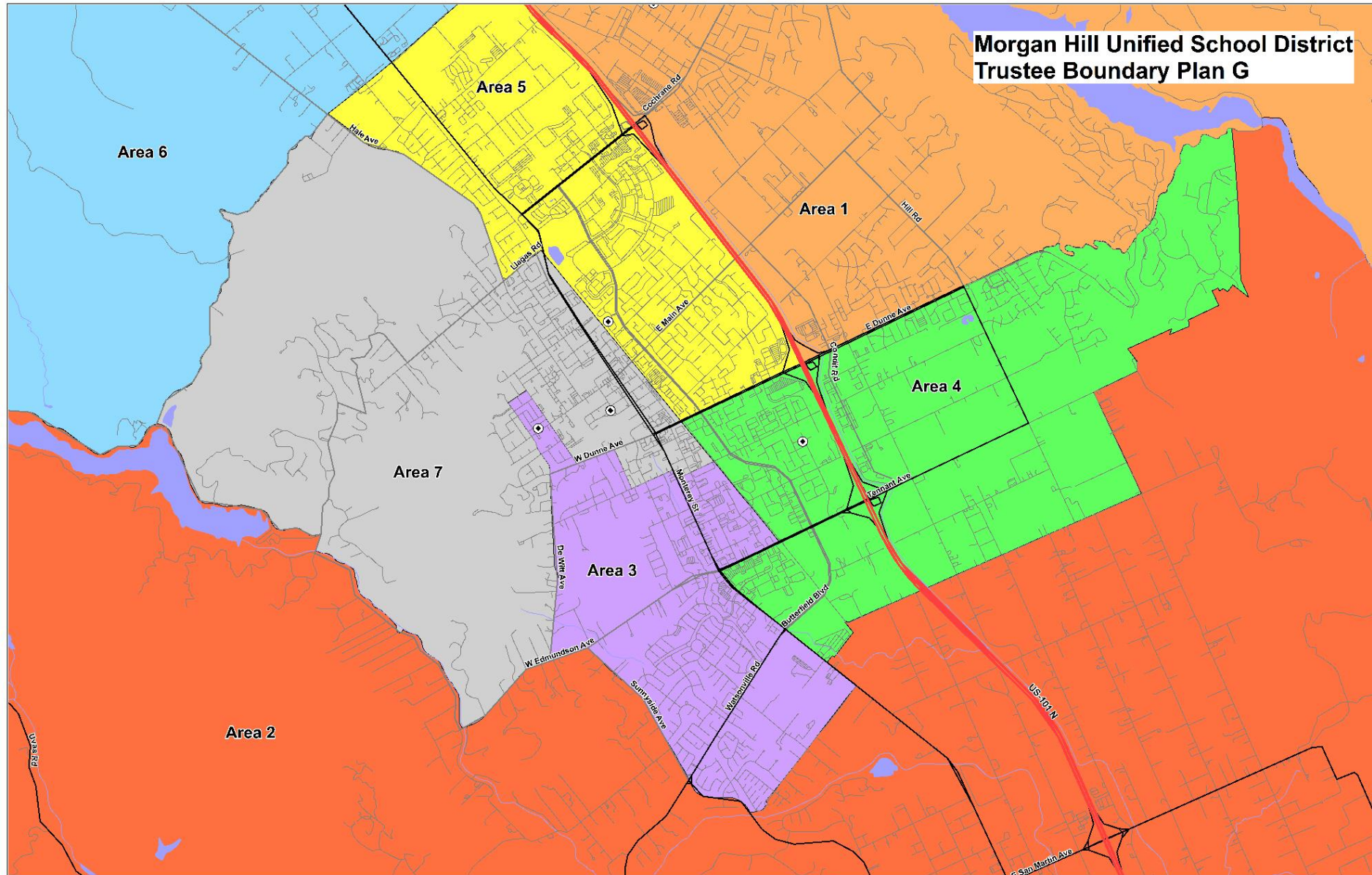

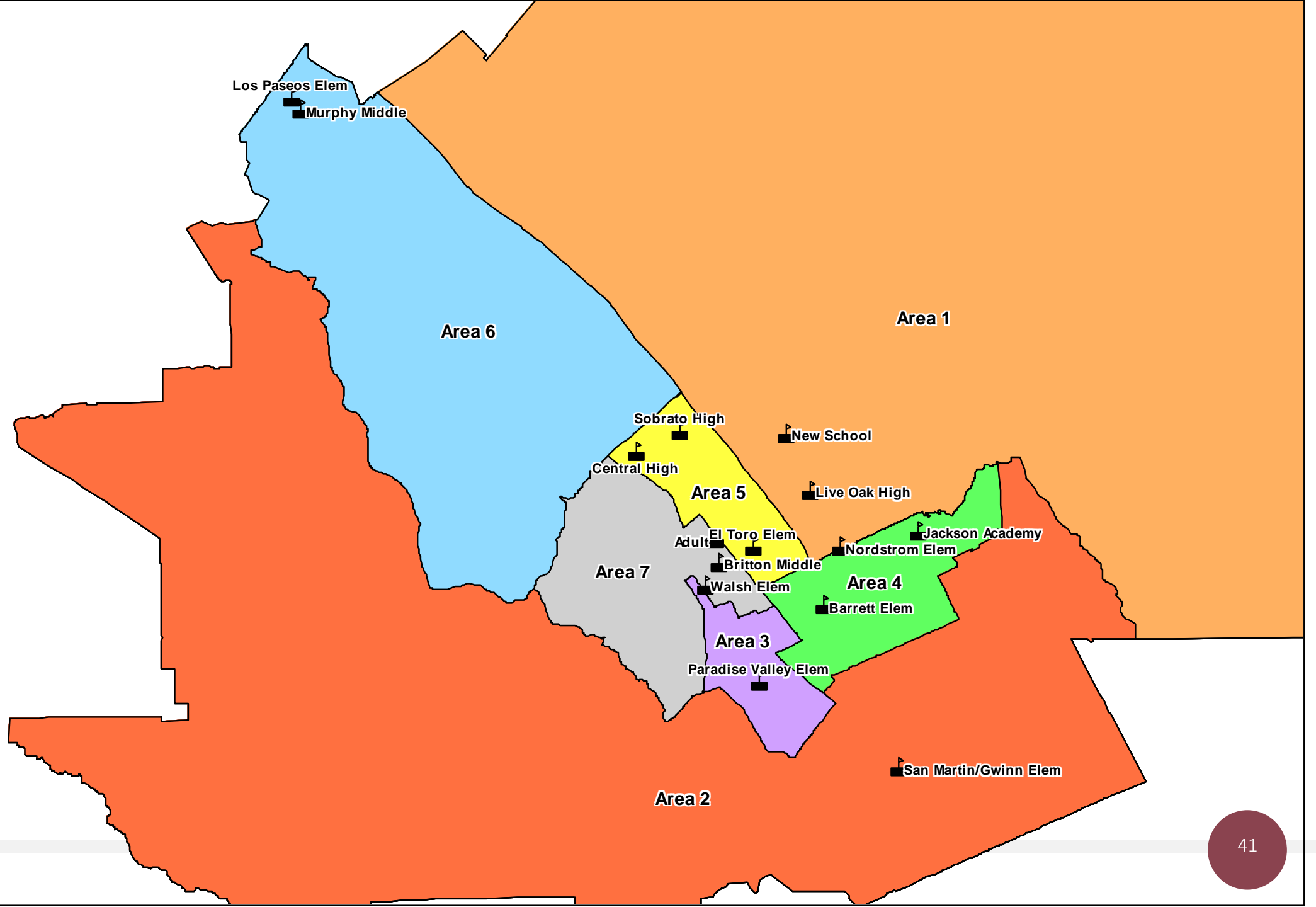
Trustee Area Boundary Map G
