Enclosed is the ballot material for election to CSBA's Delegate Assembly from your region or subregion. It consists of: 1) the ballot (on red paper) listing the candidates, the reverse side of which contains the names of ALL current members of the Delegate Assembly from your region or subregion; and 2) the required candidate biographical sketch form and, if submitted, a resume. In addition, provided is a copy of the ballot on white paper to include with your board agenda. **Only the ballot on red paper is to be completed and returned to CSBA. It must be postmarked by the U.S. Post Office on or before Tuesday, March 15, 2022.**

Your Board may vote for up to the number of seats to be filled in the region or subregion as indicated on the ballot. For example, if there are three seats up for election, the Board may vote for up to three candidates. However, your Board may cast no more than one vote for any one candidate. The ballot also contains a provision for write-in candidates; their name and district must be clearly printed in the space provided.

The ballot must be signed by the Superintendent or Board Clerk and returned in the enclosed envelope; if the envelope is misplaced, you may use your district's stationery. Please write **DELEGATE ELECTION** prominently on the envelope along with the region or subregion number on the bottom left corner of the envelope (this number appears at the top of the ballot). If there is a tie vote, a run-off election will be held. Results will be published by May 11, 2022.

All re-elected and newly elected Delegates will serve two-year terms beginning April 1, 2022 – March 31, 2024. The next meeting of the Delegate Assembly takes place on Saturday, May 21 and Sunday, May 22, 2022. CSBA should continue to advocate at the state and federal levels for sufficient resources for academic and social-emotional recovery programs.

**Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly.**

I am interested in having an impact at the state level since many of the areas that I see as most important to our students are defined by state law. This pandemic provides us with a unique opportunity to review our current educational system and drive changes that will especially help those students who are not best served by the current system.

My strengths are in working with people from many different backgrounds to achieve our goals. I am a fast learner and very good at looking at things strategically. My background is in high tech, both as an engineer and marketing director, so I have a good understanding of business and technology. I've also been a life-long learner, public school educated, who has always been a strong supporter and advocate for education.

**Please describe your activities and involvement on your local board, community, and/or CSBA.**

I am in the last year of my first term as Board Trustee and was President last year. In that role, I have been our SCCSBA representative my whole term, as well as board representative for various committees. I have been very active with my kid's schools, including being foundation President for both the high school and elementary district, raising significant money to fund programs at the schools. Other roles I held include supporting our local schools was as chaperone lead for our marching band and the lead for our math docent program at Argonaut Elementary. I am also very active in our community through several organizations, including being the current President of our Friends of the Library organization which runs a local bookshop in addition to raising money via memberships.

I have joined CSBA in their Legislative Action Day when we could go in person, and joined as many meetings with legislators as I could when it was virtual. I regularly attend the AEC and our whole board completed the Masters in governance program as a group. As our SCCSBA representative, I also was the Hoffmann Awards program chair last year.

**What do you see as the biggest challenge facing governing boards and how can CSBA help address it?**

While getting through the pandemic is still our most important focus today, it has provided a lot more visibility to the other challenges our districts and students are facing in the state. Funding levels will always be the most important area to focus on and continuing to increase state support for public education is critical. Two areas I would focus on are relieving the increasing burdens of STRS and PERS funding requirements, and maintaining LCFF funding levels through the decreasing ADA levels at many schools.

CSBA could also help districts with managing the increasing mandates being placed on schools. While programs like universal meals, COVID testing and contact tracing, TK, Ethnic Studies, etc. are all good in principle, they require major investments by school districts to support them with no help from state or local agencies, some of which might be better able to handle them. These requirements are also leading to major increases in the stress in our staff.
