

**RESOLUTION OF THE GOVERNING BOARD
OF THE MORGAN HILL UNIFIED SCHOOL DISTRICT
REGARDING RELEASE AND REASSIGNMENT OF CERTIFICATED ADMINISTRATIVE
EMPLOYEES PURSUANT TO
EDUCATION CODE SECTION 44951**

WHEREAS, the provisions of California Education Code section 44951 requires that a certificated employee holding a position requiring an administrative or supervisory credential be notified if the Governing Board determines that he or she shall be released from his or her position for the following school year;

WHEREAS, the employee(s) listed in Exhibit A to this Resolution are certificated employees holding administrative or supervisory positions who have been employed by the District during the 2021-22 school year; and

WHEREAS, the Board of Education has received a recommendation from the District Superintendent or designee to release and/or reassign the employee(s) whose names are listed in Exhibit A; and

NOW, THEREFORE, BE IT RESOLVED that this Governing Board authorize the District Superintendent or the Superintendent's designee to notify the administrator(s) listed on Exhibit A attached hereto of the Governing Board decision that they will be released from their present assignment(s) for school year 2021-22 school year, and reassigned to another position(s) for the 2022-23 school year, if the employee has reassignment rights pursuant to Education Code 44894. The District Superintendent or the Superintendent's designee is further authorized to take any further action necessary to carry out the intent of this resolution. Appropriate written notice in accordance with the provisions of Education Code section 44951 shall be served upon the above-referenced individuals by the Superintendent or designee in accordance with the provisions of law.
