I have served on the school board for 12 years and was just reelected to my 4th term. During my time on the Board, I have been a key advocate for education in our community and with our state legislators, who often turn to me for school governance advice. I want to take my passion to CSBA. My leadership includes being instrumental in the passage of our district's first parcel tax and serving as Board President for 3 years. In addition to running the parcel tax campaign in 2006, I helped pass a parcel tax extension in 2010 and a bond measure in 2014. I have been a leadership training facilitator and parliamentarian for various organizations.

Before the school board, I was a member and chair of the San Jose Library Commission. I have served on the school board during the recession and during restoration of funding. I helped start the East Side Alliance, regularly attend the First Friday lunches with board members, and have served as a panelist for SCCSBA's new Board member training. I also acted as a liaison between the city and school district on several key projects.

What do you see as the biggest challenge facing governing boards and how can CSBA help address it? (Character count limit: 700)

I understand the difficulties of districts that are at the low end of the revenue limit scale and those that are experiencing declining enrollment. CSBA needs to understand how the state's economic challenges, including high cost of housing, over-reliance on personal income taxes, and crumbling infrastructure affect school districts. CSBA should help facilitate regional cooperation between school districts and cities to address these issues. I will continually advocate for full and fair K-12 funding. California should strive to be in the top 10 in per pupil funding, not in the bottom 10. We should be at the top in teacher, librarian, counselor, nurse and administrator ratios.


